## **LLM** - Master of Laws

The LLM (Master of Laws) course represents a modern form of manager education. Graduates get better job placement, move up the career ladder and have a chance to get a higher financial reward. The LLM course is suitable for applicants with a legal education, but also for executives, owners of business companies or representatives of middle and senior management who want to learn information on the legal and economic background of the functioning of corporations. The time flexibility of the study allows it to be adapted to one's own possibilities and preferences.

#### **Conditions of admission**

A condition for admission to the LLM program is a completed university education at least at the bachelor's level, or professional education in the BBA program. However, the applicant may be granted an exception if he can prove his managerial experience.

## **Start of teaching**

Course can be started at any time throughout the year. There is no need to wait for the start of your studies or to worry that your chosen program will not open. You can start studying at ESBM at any time.



## Form of study

To improve the quality of LLM course, ESBM uses a combination of online study with the Oxford tutor model. This type is peculiar mainly to foreign universities and differs from Czech academic studies mainly in its practical focus.

## **Course of study**

The LLM course lasts a year and is conducted online in combination with interactive seminars. It is divided into two blocks and each block is further divided into individual modules which are led by professional lecturers. The output for each block is seminar papers or case studies. The study is concluded with the preparation of the final thesis and its defense. After meeting all requirements, the graduate receives the professional degree LL.M., which is listed after the name.

#### 1. BLOCK -SPECIALIZED

8 MODULES 3 COURSE DAYS First block is identical for all students and is divided into three course days. It contains eight basic modules: Private Law, Corporate Law, Contract Law, Financial Law, Competition Economics, International Trade Law, Insolvency Proceedings and Liquidation and Labour Law.
