

CONSENT TO THE PROCESSING OF PERSONAL DATA

1) The student gives consent to the

in accordance with Act No. 110/2019 Coll., on the protection of personal data, as amended, and Regulation 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC, to process such personal data: first name, surname, date of birth, permanent residence, contact address, telephone, email for the purpose of fulfilling the rights and obligations arising from the concluded Study Agreement and the General Terms and Conditions of Study during the period of study, in particular to ensure the organization of the study, communication of information related to the study, execution of the certificate of completion of studies and other services provided by the Administrator. For five years after the end of the study, the Administrator will keep this data for the purpose of sending necessary information resulting from this contract and information in the form of commercial communications within the meaning of Act No. 480/2004 Coll., on certain information society services and on amendments to certain acts. At the same time, the student gives consent to the taking of photographs and recordings of his/her person at events held by ESBM – seminars, educational events, graduations and other events. These may be placed on the web presentations of the Administrator or on its social networks. Such records and photographs will not be provided to third parties together with personal data such as name, surname, date of birth.

Personal data may only be used by designated employees and may also be disclosed to competent authorities authorized under applicable law.

The processing of personal data is carried out by the Controller, but personal data may also be processed for the Controller by the following processors:

accounting agency, tax advisor, accounting software provider iDoklad, Google Analytics software provider, SmartEmailing software provider, and possibly other providers of processing software, services and applications, which are not currently used by the Company.

Personal data will not be transferred to third parties for the purpose of sending commercial communications within the meaning of Act No. 480/2004 Coll., on certain information society services and on amendments to certain acts.

The Student expressly consents to the above processing. It is an active and voluntary expression of the Student's will, which has not been forced and this consent has not been conditioned in any way.

Consent can be withdrawn at any time after the end of the study, for example by sending an email or letter to the contact address of the Administrator.

The student acknowledges that under the Data Protection Act he/she has the right to:

- withdraw consent at any time, in which case the Student will be advised of all the consequences of such withdrawal,

- request information about which of his/her personal data the Controller processes,
- request an explanation regarding the processing of personal data,
- request access to this data from us for updating and correction,
- request the deletion of this personal data,
- in case of doubt about compliance with the obligations related to the processing of personal data, contact the Controller or the Office for Personal Data Protection.
